## TRAINING DESCRIPTION

The Protection of Sovereignty Act, 2026 has transformed the treatment of foreign funding; the Employment (Amendment) Act, 2025 has overhauled the obligations of every employer; and successive tax amendments have reshaped how NGOs and their donor-funded programmes are taxed, all against a backdrop of tighter enforcement and shrinking donor support.

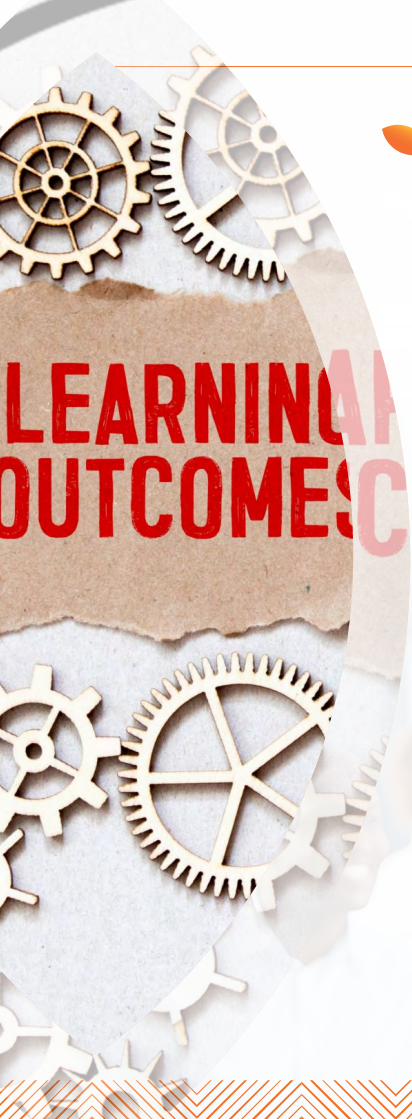
The 2026 symposium will equip NGOs to understand and adapt to these sweeping legal changes, turning a wave of new obligations into a clear, practical compliance strategy for the year ahead.

- Tax Readiness for NGOs in a Reforming Landscape: The Latest Tax Amendments, Exemptions, VAT, Withholding Tax, PAYE and the Taxation of Donor-Funded Programmes
- The Future of Employment Law for NGOs: Navigating the Employment (Amendment) Act, 2025, AI in the Workplace, Emerging Compliance Risks and Sustainable Workforce Management
- Strategic Compliance and Donor Accountability: Managing Foreign Funding, Donor Conditions, Grant Compliance and Organisational Independence in a Shrinking Funding Environment
- From Aid to Enterprise: Sustainable Financing, Social Enterprise and Income-Generating Models, and the Legal, Tax and Governance Questions They Raise

- Data Protection and Digital Compliance for NGOs: Meeting Obligations under the Data Protection and Privacy Act across Beneficiary, Donor and Staff Data

- Meet data-protection obligations over beneficiary, donor and staff data.
- Network and forge collaborations with peers, regulators and partners.
- Advocate effectively for progressive and workable policy and legal reform.
